

# KING'S COLLEGE LOAN REQUEST FORM--PA GRADUATE STUDENTS

In order for the financial aid office to certify a Federal Direct Stafford loan on your behalf, you must tell us how much you wish to borrow, and which semesters you wish your loan to cover. The amounts listed below are the maximum a graduate student may borrow:

**\$20,500 Unsubsidized Stafford for every two semesters** By law, a graduate level student may borrow a maximum of \$138,500. Note: a new request form is required every two semesters.

**PLEASE NOTE:** To be eligible for a loan, students in the Physician's Assistant programs must have a **2013-2014** Free Application for Federal Student Aid (FAFSA) on file, have completed the Federal Direct Stafford Loan Master Promissory Note (MPN), and maintain satisfactory academic progress. If you have not filed the FAFSA, you may do so online at [www.fafsa.gov](http://www.fafsa.gov). If you have not completed the MPN, you may do so online at [www.studentloans.gov](http://www.studentloans.gov).

In addition, PA II, and III students who have borrowed \$20,500 for two semesters of enrollment in Federal Direct Stafford loans, but who need additional loan funds, may borrow from the Federal Direct Graduate PLUS loan program. In addition to the eligibility requirements listed above, you must also complete a separate Federal Direct Graduate PLUS loan Master Promissory Note and Graduate Plus Entrance Counseling at [www.studentloans.gov](http://www.studentloans.gov).
