**Aid Request:** Eligibility for grants (such as the Federal Pell Grant) will be considered automatically for all undergraduate students enrolled in the Summer 2026 semester. **Eligibility for both undergraduate and graduate federal student loans will only be considered if you indicate interest below.**

**Federal student loans** may be available for students that have not already borrowed their annual and/or aggregate maximums and who meet all other Title IV aid eligibility criteria.

- Students **must be enrolled at least half-time (6 credit hours for undergraduate students and 3 credit hours for graduate students)** to qualify for federal student loans.

Summer 2026 aid is based on unused eligibility from the **2025-2026** academic year. You must have a **2025-2026** FAFSA completed by **06/30/26** to qualify for Summer 2026 federal aid.

If you do not meet SAP requirements after spring grades are posted, you may lose eligibility for summer aid. *\*\*I give my permission to the Financial Aid Office at King's College to certify a Direct Loan for the summer semester. I understand that approval of my request is dependent upon my determined eligibility. I understand that I must repay my federal Loan in full and that I may not borrow more than the total loan aggregate allowed by federal regulations.*
