Changes to the Sexual Misconduct Policy (Title IX)

Page 173, Student Handbook, Sexual Misconduct Policy, add the following

XII: Anonymous- Jane or John Doe Report

The College provides an anonymous reporting site for students, employees and persons external to the College at https://www.kings.edu/life_at_kings/dean_of_students/confidential_reporting . Information submitted on the site is accessed by the Title IX Coordinator(s). No other staff has direct access to the information. The Title IX Coordinator will forward the report to the Title IX investigators, and when there is sufficient information to the hearing officer and appeal officers for adjudication. When there is not enough information for adjudication the information will be kept by the Title IX Coordinator and the report will be recorded in the Title IX statistics without information to identify the reporter or accused.

Page 177, Student Handbook, Sexual Misconduct Policy, add the following:

Clarification of the Reporting Victim Immunity from College Student Code of Conduct actions.

Victims are encouraged to report any alleged violation of the Sexual Misconduct Policy (Title IX) to the College, local authorities and support services on and off campus. When a victim makes a report to the College through the Title IX Coordinator, if alcohol and drug usage was involved in the incident, the victim will not be subject to action through the Student Code of Conduct for the consumption, possession or use of alcohol or drugs.
