- I will be required to submit documentation that I have tested negative for COVID-19 within 24 hours of arriving on campus.
- I may be required to submit to periodic COVID-19 surveillance testing throughout the academic year Fall 2022 – Spring 2023 semesters.
- If I am a close contact of a COVID-19 positive person, I will be required to quarantine.
- If I test positive for COVID-19, I will be required to isolate and may be asked to leave campus.
- If I am required to quarantine or isolate, I am not guaranteed synchronistic access to my courses.
- I will be required to comply with additional COVID-19 public health and safety requirements, including mask wearing, social distancing, and other items determined by King's College and/or public health agencies and subject to change.
