If you wish to borrow a Federal Direct Stafford loan you must tell us **EACH SEMESTER** how much you wish to borrow. The amounts listed below are the maximum a student may borrow for every two semesters of enrollment based on grade level and dependency status:

## DEPENDENT STUDENTS

Freshmen (0-29 credits earned) \$3,500 (subsidized) + \$2,000 unsubsidized) = \$5,500 total

Sophomore (30-59 credits earned) \$4,500 (subsidized) + \$2,000 unsubsidized) = \$6,500 total

Junior, Senior, and 5<sup>th</sup> year (60+ credits earned) \$5,500 (subsidized) + \$2,000 unsubsidized) = \$7,500 total

## INDEPENDENT STUDENTS AND DEPENDENT STUDENTS WHOSE PARENT HAS BEEN DENIED A PLUS LOAN

Freshmen (0-29 credits earned) \$3,500 (subsidized) + \$6,000 unsubsidized) = \$9,500 total

Sophomore (30-59 credits earned) \$4,500 (subsidized) + \$6,000 unsubsidized) = \$10,500 total

Junior, Senior, and 5<sup>th</sup> year (60+ credits earned) \$5,500 (subsidized) + \$7,000 unsubsidized) = \$12,500 total

By law, a dependent undergraduate may borrow a total of \$31,000. An independent undergraduate may borrow a total of \$57,500.

**PLEASE NOTE:** To receive a loan you must:

have a Federal Direct Stafford Loan Master Promissory Note (MPN) on file  maintain satisfactory academic progress.

be enrolled for a minimum of 6 credits for the semester  have a current year FAFSA on file

If you have not filed the FAFSA, you may do so online at [www.fafsa.gov](http://www.fafsa.gov). If you have not completed the MPN, you may do so online at [www.studentloans.gov](http://www.studentloans.gov).
