Scholarship Funds

The African Student Scholarship

To provide a King's education to worthy students who are residents of an East African country.

The Guy A. and Norma J. Agati Memorial Scholarship

Established in memory of her husband, Guy A. Agati, by Norma Agati, a former member of the Board of Directors of King's College. After Mrs. Agati's death, their daughter renamed the scholarship to honor both of her parents. Recipients are selected on merit and need.

The Maria T. Alexander Health Professions Scholarship

Established by Dr. Patrick Kerrigan, physician for the Alexander family, to honor the memory of Maria Therese Alexander, the daughter of King's professor, Dr. Chris Alexander '79 and Melissa Alexander '85. Students in premedical fields who have need are eligible.

The Alumni Scholarship

This scholarship was established through the proceeds of sales from the Alumni Collection. It is intended to assist children of alumni who choose to follow in their parents' footsteps to attain an undergraduate degree from King's College.

The Paul J. Arthur and Margaret T. Arthur Scholarship

This scholarship was established by the late Margaret T. Arthur to assist students in need of financial assistance. Preference is given to residents of Luzerne County, Pennsylvania.

The Eleanor Babonis Physician Assistant Scholarship

Established by alumni, family and friends of Eleanor Babonis upon her retirement as the Program Director of the Physician Assistant Program. Intended to aid a first year professional phase student as he/she embarks on the didactic portion of Physician Assistant training.

The Joseph W. and Ann P. Balz Memorial Scholarship

The award is given in memory of Ann P. Balz, the first employee of the College, who contributed greatly to the early administration of the school, and who remained a devoted friend and loyal supporter her entire life, and in memory of Joseph W. Balz, a member of the first graduating class of King's College in 1950, who was employed by King's College from its founding in 1946 until 2017—more than 70 years. Joe was instrumental in transforming the College and its campus from modest beginnings to the expansive campus and academically-recognized college it is in 2017.

The Charles F. and Beatrice Balz Scholarship

Established in 2011 by Charles F. Balz, Class of 1950, in recognition of the valuable education provided by Holy Cross Fathers.

The Marjorie Bart Scholarship

Established by the children and friends of the late Marjorie Bart, who had served as secretary for the Athletic Department for almost 20 years.

The Albert and Mary Bellsey Scholarship

This scholarship was established by a bequest of Albert and Mary Bellsey, neighbors of King's College.

The Stanley B. Benjamin Family Scholarship

For a resident of Northeastern Pennsylvania in financial need.

The Dr. Anthony D. Berard, Jr. Scholarship

Established by the Mathematics
Department in honor of Tony Berard's forty years of distinguished service, to support a junior or senior majoring in mathematics who has demonstrated exceptional talent in abstract reasoning.

The Earl N. Blasi Scholarship

Established in the McGowan School of Business by Earl N. Blasi, former member of the Advisory Council, the scholarship aids local students at King's College.

The Mr. and Mrs. John Bonin Endowment

Established by Mrs. John Bonin.

The Peter Bosack Scholarship

Established by the Estate of Peter Bosack, a member of the first graduating class of King's College--1950, this scholarship provides assistance to a student from Northeastern Pennsylvania with a high school or King's G.P.A. of 3.0 or above. Preference is given to first-generation college students.

The Bowblis Economic Consulting Award for Excellence in Economics

This scholarship was established by John R. Bowblis, Ph.D. of the King's College Class of 2002. This scholarship is intended to assist a top Economics Major entering their final year at King's College. If no students are eligible, the award may be given to an outstanding underclassman Economics Major and this student may receive the award only one additional time. Preference is given to a student who intends to pursue his/her education in Economics beyond King's College.

The Dr. Brian K. Bower Scholarship

Established by the Political Science Department at King's College to support a student who demonstrates strong potential in the field of Political Science.

The Dr. James LeBaron Boyle Scholarship

Proceeds from the fund are presented to exceptional students in recognition of their having studied literature and the arts in Europe.

The Terry and Agnes Brennan Scholarship

A four-year scholarship for a talented and hard-working senior at Holy Redeemer High School, Wilkes-Barre, or Marian Catholic High School, Tamaqua, Pa., who plans to attend King's College.

The Brigham Dougher Scholarship

This Scholarship was established by alumni Marianne Brigham '84 and Brendan Dougher '84. The scholarship is to be awarded for two academic years. The Scholarship is to rotate between the Masters in Science Healthcare Administration and Accounting programs. For the Accounting Program Scholarship, it shall be awarded to the same student for their freshman and sophomore vears - the student shall maintain a cumulative GPA of 3.0 at the conclusion of their freshman year to be awarded the scholarship for their sophomore year. As the Master in Science Healthcare Program is a 37 credit program, two students will be awarded a one-year scholarship in consecutive years. The Scholarship cycle shall commence with a Masters in Science Healthcare Program award.

The Carl J. Broghamer Scholarship

The Butchko Family Scholarship at King's College

This merit-based scholarship will be awarded to a graduating Wyoming Area

High School Senior who has enrolled and will attend King's College as an incoming, full-time freshman student for the Fall semester following their high school graduation.

The Dr. Donald I. Buzinkai Memorial Scholarship

A need based scholarship for deserving students, this scholarship was established in memory of Dr. Donald I. Buzinkai, a long-time member of the King's College Political Science Department.

The fund now endows the Brandon J. Case Memorial Scholarship, which is awarded to an outstanding History major or Geography major.

The Centennial Scholarship of the Episcopal Diocese of Bethlehem

Established by a gift from the Diocesan Council of the Diocese of Bethlehem to commemorate its centenary.

The Century Club Scholarship

Established by the King's College Century Club members.

The Gene Chismer Memorial Scholarship

Established by a group of alumni and friends to honor the memory of Gene Chismer, Class of 1954 and varsity lineman on the Monarch football team.

The Ann Rhoda Chopick Memorial Scholarship

Established from the generosity of Ann Rhoda Chopick through an estate gift, this scholarship will assist King's College students studying in undergraduate business programs.

Established by the G.A.R. for residents of Luzerne County, with preference given to descendants of Civil War veterans.

The Greater Pittston Friendly Sons of St. Patrick James A. Gilmartin Scholarship

This scholarship was established by Jim Gilmartin, King's Class of 1962, in 2000 and is available to a senior from Pittston Area or Wyoming Area high schools who has been accepted at King's College. It is a four-year award with a total value of \$60,000.

The Greater Wilkes-Barre Friendly Sons of St. Patrick Scholarship

Established by the Greater Wilkes-Barre Chapter of the Friendly Sons of St. Patrick for a qualified student of Irish descent residing in the Wyoming Valley.

The Betty and Carl Gross Memorial Scholarship

This is a scholarship for needy students, established through the estate of Mrs. Betty Gross.

The Norbert A. and Victoria F. Gustitus Memorial Scholarship

This scholarship was established by the Trust of Norbert A. Gustitus for students who are financially in need of assistance

and who are academically qualified to attend King's College. The recipients of the scholarship shall be determined by the Trustee in consultation with the Dean and/or Administrator of King's College.

The Vincent F. Gutendorf, Jr. Memorial Scholarship

The William Randolph Hearst Endowed Scholarship

A grant from the William Randolph Hearst Foundation established this scholarship for first-generation students, with a particular preference for minority students.

The Hugh G. and Edith Henderson Scholarship

Established by a bequest of Jessie T. Henderson for full-time students residing in the Wyoming Valley.

The Holland Family Scholarship

The scholarship was originally established by William Holland '52 in memory of his brother, Jerome, to assist students in accounting. In 2019, members of the Holland family renamed the scholarship to memorialize brothers Jerome, William and Robert Holland.

The Holy Cross Brothers Scholarship

Previously known as the Holy Cross Brothers' Student Loan Fund, established in 1995 as an endowed scholarship to support upper class students.

The Holy Cross Minority and International Scholarship

Created by the Eastern Province of the Holy Cross fathers and brothers for minority and foreign students to enrich a King's College education with broader cultural diversity.

The Holy Cross Scholarship Fund

Established and maintained by the Holy Cross priests and brothers at King's College.

The John A. Hourigan, Jr. Scholarship

Established in memory of John A. Hourigan, Jr. by his son, David P. Hourigan, to assist students of academic ability who demonstrate financial need.

The Sylvia A. Hughes Memorial Scholarship

This scholarship was established through an estate gift from Sylvia A. Hughes. It was her desire to assist students in need who participate in the College's Theatre Program. Mrs. Hughes had a great love for the theatre and often attended productions at the College's Theatre.

The Bruce W. Hulbert Memorial Scholarship in Finance

Established to honor the memory of Bruce W. Hulbert, Chairman, President and CEO of Mellon Bank, N.A., Northeastern Region, to support an undergraduate or graduate student in the field of finance.

The Albert J. Iannuzzo Scholarship

Established by Professor Ann Joyce in memory of her father, for students with creative potential in mass communications.

The InterMetro Scholarship

Established by InterMetro Industries Corporation for qualifying sons or daughters of its employees.

The International Brotherhood of Electrical Workers Local Union 163 Scholarship

The International Brotherhood of Electrical Workers Scholarship Endowment was established in 2009 to give young people in the Local 163 region the opportunity to attend King's College and to realize their potential.

The Robert Jennings Memorial Scholarship

Established by the College, friends, and fellow students of Rob Jennings, Class of 1988.

The Gertrude Brady and Laura Jones Scholarship

Established through a bequest of the late Laura Jones to provide financial assistance for young men accepted to King's College.

The Margaret A. Judge, MSN, Scholarship

Established by Joseph M. Judge to support the education needs of nursing students.

The Christopher F. Karmonick Scholarship

To honor the memory of Christopher F. Karmonick, Class of 1989, who passed away in 1988, this fund was established by his parents, Mr. and Mrs. Francis J. Karmonick, and Lawrence M. Klemow and David L. Glassberg, to assist a student from the Hazleton area majoring in business.

The Kearney & Company Scholarship

Founded in 1985 by King's College alumnus Edward F. Kearney '74, Kearney & Company provides auditing, accounting, and consulting services to the Federal Government and its agencies throughout the country. Thanks to a generous annual gift, one scholarship will be made available annually for one rising senior who majors in Accounting. Qualified applicants must: (1) demonstrate academic merit by maintaining a minimum cumulative GPA of 2.5; and (2) currently be working at least parttime and/or involved in extra-curricular activities while attending King's. Interested candidates will submit an essay detailing the extent to which he or she has had to work to pay for his or her education, any civic involvement, and any

involvement within the King's community and beyond. The essay should describe what this award would mean to him or her personally and how it would impact his or her education. The essay is limited to 500 words. The scholarship will be publicized in the spring semester, with a deadline for essay submission no later than April 1. A selection will be made with input from: (1) a representative of Kearney & Company: (2) the Dean of the McGowan School of Business (in consultation with the Chair of the Accounting Department); and (3) the Director of Financial Aid. The award will be made in August before the student recipient's senior year at King's.

The James E. Kelly, C.S.C., Scholarship

Established by Mr. and Mrs. Robert McLaughlin in honor of Rev. James E. Kelly, C.S.C., with preference given to a sociology major.

The King's College Employees Scholarship

Established by the employees of King's College during the Legacy of Excellence Capital Campaign, this scholarship assists King's students from the Wyoming Valley with high financial need.

Established by Robert Laux, former President of the Century Club, to aid needy students.

The Jane M. Lenahan Memorial Scholarship

Established by the sons and daughters of Jane M. Lenahan of the Career Planning and Placement Office to benefit students who demonstrate financial need.

The Dorothy C. Leonard Scholarship

Established by William J. Leonard '75 and his wife, Anita, to honor the memory of his mother by assisting needy students.

The Morlyn Lesho Memorial Scholarship

Established by the family and friends of Morlyn Lesho, a Biology student at King's College, this scholarship is given to students in their junior year who demonstrate financial need, with preference given to Eagle Scouts or Girl Scouts who have earned the Gold Award.

The Martin Reardon Memorial Scholarship

Scholarship in accounting established in the McGowan School of Business in honor of Martin Reardon '66.
